We do not collect sensitive data, such as race, religion, or health information.

# 3. How We Use Your Information

We use the collected information (Name, Year of Study, University) to provide the following services:

Allow users to compare mock exam scores on a leaderboard.

We also allow the user to opt out of the leaderboard service and continue to use our service anonymously.

Generate graphs to compare user performance.

Securely manage user accounts and provide password encryption.

We may use your email address to send you important information, updates, or newsletters related to the ReadyVet app.

You may also receive emails from us to reset your password if you request such assistance and One time passwords when making an account

# 4. Legal basis

We rely on legitimate interests to process your data for the purposes set out above. It is a legitimate interest of ours to collect and use the data to provide the services offered, and to ensure that we can secure and manage accounts.

It is also a legitimate interest of ours and yours that we are able to send you important information and updated, and reset passwords. Promotion of our product is also a legitimate interest.

#### 5. Information Sharing

We will share your personal data with third parties where required by law, where it is necessary to administer the working relationship with you or where we have another legitimate interest in doing so

If ever in the future, we are considering restructuring the company, we may share your information with the other parties involved and with the relevant professional advisors. This is for our legitimate interests in making sure that potential buyers and partners have the information that they need about the business.

We may also share your personal data with third parties if we have a legal obligation to do so or for the purposes of fraud protection and credit risk reduction.

We may share your personal data with third party service providers who act on our behalf such as IT services providers and our professional advisers. Where it is necessary to do so, we may need to share your information with them, so that they can carry out the services we have requested.
